1. **Application.** Submit complete application to **P.O. Box 2105 Newnan, GA 30264**, including signature of homeowner.
2. **Phone Interview.** You will receive a phone call from an administrator of RiverLife, Inc. to discuss your home repair needs and clarify the information given.
3. **Home Visit.** A staff member or volunteer with RiverLife will make an appointment to visit your home to identify and assess the work needed. The homeowner should be present for this visit.
4. **Approval/Denial.** If approved, administrators will assign the project to a group of volunteers according to skill and availability and begin the scheduling process for completing the project. If denied, you will be notified in writing by an administrator with the reason for denial and possible referral to other organizations for assistance.
